### **MEMBERSHIP CRITERIA**

#### **§ 3**

Full membership of the association can be obtained by a private person or an officially recognized society licensed by the authorities to pursue private investigation. Equally full membership can be obtained by a person with a bachelor's or a master's degree in law active in a field tangential to private investigation. The association may also accept as a member a person with qualification to head a security guarding company and also a person active in a field tangential to private investigation. The association may also accept supporting members and honorary members. The decision of accepting a new member is made by the board. Every member must be listed in the catalogue of members. During meetings of the association only fully accepted members have the right to vote. A supporting member is allowed to a say at the meeting.
