In the framework of the HDA Academy regular professional lectures and exchanges of expertise in online and in-person formats were organised in topics most relevant for the membership. To raise awareness and facilitate the lawful conduct of business special emphasis was given to the European Union General Data Protection Regulation (GDPR).



In October 2022 the XIII IKD General Assembly took place in Budapest, Hungary with more than 70 participants from 16 member countries. As part of the conference participants gained in-depth insight into the situation of private investigation in Hungary and discussed possibilities for cooperation in private security related education in IKD member countries.
